Good Morning,

Happy Spring.....we hope that you are safe and well!

New beginnings and new opportunities to save money await your agency/university/institution as, once again, the enrollment period for the Department of Administration's insurance premium discount programs has begun. Read on to learn more about how your agency/university/institution may reduce the cost of its property/casualty insurance premiums through participation in loss prevention initiatives offered by the Risk Management & Tort Defense Division. During FY2021, approximately \$1,100,000 in insurance premium discounts were awarded!

Auto Insurance Discount

Your agency/university/institution may receive a 10% auto insurance premium discount in FY2023 by sending 5% of its employees to safe driver training during FY2022. Participation may also qualify those employees for discounts on their personal auto insurance (note: discounts vary by insurance carrier). Over 24,000 state/university/institution employees have attended safe driver training since FY2000. General Liability (Cyber) Insurance Discount

Your agency/university/institution may receive a 2.5 percent general liability discount in FY2023 if 75% of your employees (50% for the Montana University System) participate in online cyber/information security training offered, or approved by, the State Information Technology Services Division (SITSD) on or before June 1, 2022. Any employee involved in a cyber/information security data incident that results in a claim during FY2021 must participate in the training during FY2022 unless excused by the Department of Administration. Your agency or university may qualify for the discount by following the instructions at https://rmtd.mt.gov/insurance/cyberinsdisc.

High Deductible Discount

Another way to save money is through higher insurance deductibles. Your agency/university/institution may realize insurance premium discounts between 5% and

20% in FY2022 by opting for higher deductibles on property insurance and/or auto physical damage insurance. To learn more, please visit our website at https://rmtd.mt.gov/insurance/highdeddisc.

Property Insurance Discount

In addition, your agency/university/institution may save 10% on its property insurance in FY2023 by developing comprehensive and effective property loss management programs during FY2022. An effective property loss management program will help to protect your physical assets and human resources from damage, injury, and/or loss.
